

It is an opportunity for delegates to get advice about the management of a difficult or unusual current case, as well as a chance to discuss how a particularly challenging problem has been treated, to see if the 'experts' at the meeting would have done anything differently. In order to improve the educational value of this session the IPSO Executive Committee and Scientific Committee are introducing some new arrangements for this session, so that it can be more structured.

There will still be the option for delegates to bring current problems to the meeting without prior submission, to assist with decisions about management of the child. To be certain that your case is discussed please submit deatils one month prior to the meeting, ie by 23 August., but later submissions will still be considered provided there is time.

#### Plans for the IPSO Dinner

Thursday 26 September

The Annual IPSO Dinner will be held on the evening of Thursday 26 September, at the end of the IPSO scientific meeting. A fun evening is planned including a harbour cruise and fine dining at a restaurant on a nearby island. We cannot confirm the venue, at present but anyone who knows Hong Kong will already be antiocipationg a very special night out with friends and colleagues.



Unfortunately the IPSO dinner is unavoidably on the same evening as the SIOP gala dinner. We recommend that all IPSO delegates attend the IPSO dinner that night, which will be much better value. We anticipate that the IPSO dinner will cost in the region of 40 Euro. Please keep an eye on the conferences page on the IPSO website for further details.

We realise that some delegates may have already paid for the SIOP gala dinner at the time of registration, but may now prefer to attend the IPSO dinner. It is usually possible to return tickets for the SIOP dinner at the meeting as there tends to be a late demand.

The local organisers will need to have some idea of numbers for the dinner in advance of the meeting, and so we plan to be in contact with IPSO members and other Hong Kong delegates nearer the time explaining how places at the dinner can be reserved.

#### **Nominations for the IPSO Executive**

Do you want to be on the IPSO Executive Committee? This is formal notification of posts which will be up for election at the AGM in Hong Kong. Sandeep Agarwala is completing his second term, and therefore IPSO members are asked to submit nominations to the secretary for a 'member at large'. Steven Warman will have served 2 years on the Executive Committee, and is also our Programme Director. Steven will stand for re-election for a second term. Dan Aronson will be completing his year as immediate past president, and so it will be time to chose a president-elect. Traditionally members have made suggestions regarding the choice of next president, and the executive Committee has made a recommendation. IPSO is a democratic organisation, and so all nominations will be accepted. The secretary will only accept nominations in writing: by post to Roly Squire, IPSO Secretary, Department of Paediatric Surgery, Leeds LS1 3EX, UK; by fax to +44 113 3925827; by e-mail to roly.squire@leedsth.nhs.uk . Please can nominations be submitted by Friday 23 August 2013, one month before the meeting. Any member can propose any other member to stand for membership of the Executive. Please ensure that the nominee is in agreement. If there is more than one nomination for either of the posts the Executive Committee will organise a ballot at the AGM.

#### Proposed changes to the IPSO Statutes

The IPSO Executive Committee is recommending two amendments to the Statutes and By-laws to meet the needs of the organisation in the light of changing circumstances. These amendments have been previously recommended to the membership, and are being announced once more to meet the statutory requirements, prior to being voted on by the members who attend the AGM on Wednesday 25 September 2013 in Hong Kong.

- 1. Amendments (1 & 2) to allow the Executive freedom to co-opt any member to fulfil the roles of Programme Director and/or SIOP Scientific Committee Representative. Following reduction in the size of the Executive Committee from 10 members to 8 members in 2008 it has become apparent that it may not always be possible to appoint these posts from the four elected "members at large".
- 2. Amendment (3) to address the new on-line application process.

#### Proposed amendments are underlined and in red

#### Amendment 1.

STATUTES:

ARTICLE 5.

The Society will have an Executive Council consisting of the Past-President, a President, a President-Elect, a Secretary and/or Treasurer, and four members at-large, included members with a specific portfolio, i.e. Program Director and SIOP Scientific Committee Representative. Their terms of office should be two years, except for the Past-President and President-Elect whose terms of office is one year and the Secretary and/or Treasurer whose term of office is three years.

Change to read:

ARTICLE 5. The Society will have an Executive Council consisting of the Past-President, a President, a President-Elect, a Secretary and/or Treasurer, and four members at-large. Their terms of office should be two years, except for the Past-President and President-Elect whose terms of office is one year and the Secretary and/or Treasurer whose term of office is three years.

#### Amendment 2.

**By-LAWS:** 

ARTICLE 3.4 The Executive Committee will call for nominations from amongst the membership for ad hoc appointments to relevant boards or committees outside the Society in order to represent the interests of the Society. Such appointments will be confirmed at the Annual General Meeting by majority vote and will be for a period of two years. Such appointees would report on an annual basis to the Executive Committee. Members accepting such

appointment <u>may apply for re-election</u> to the position on two occasions.

Change to read:

ARTICLE 3.4 The Executive Committee will call for nominations from amongst the membership for ad hoc appointments to relevant boards or committees outside the Society in order to represent the interests of the Society. The Executive Council will also be able to appoint any active member to be Program Director and/or SIOP Scientific Committee Representative. Such appointments will be confirmed at the next Annual General Meeting by majority vote and will be for a period of two years (Program Director) or three years (SIOP SC Representative). Such appointees will report on an annual basis to the Executive Committee, and may be invited to meetings of the Executive Committee if appropriate. Members accepting such appointment may be re-appointed to the position on two occasions.

#### Amendment 3.

**BY-LAWS:** 

ARTICLE 1.1New Members must be proposed by two Active Members in good standing. Application for Membership will be accompanied by a summarized *Curriculum vitae*, and will be sent to the Secretary's office at least two months before the Annual Meeting. Applications fo Active or Associate Membership will be considered at each Annual Meeting of the Executive Council and a recommendation to approve, reject or defer action made by the Council.

Change to read:

1.1 New Members must be proposed by two Active Members in good standing. Application for Membership will be accompanied by a summarized *Curriculum vitae*, and can be carried out on-line through the membership office, or can be sent to the Secretary's office. Applications will be reviewed by the Secretary, who will be able to give provisional approval, following appropriate consultation with members of the Executive Council. In order to receive the benefits of IPSO membership in relation to the Annual Meeting, new members must have paid their first subscription by a minimum of one calender month prior to the first day of the Annual Meeting.

The following paragraph will remain unchanged:

1.2 All names of Candidates for Active or Associate Membership, which have been approved by the Executive Council, will be circulated at the next Annual Meeting, an affirmative vote of of the voting Active Membership present being necessary for confirmation. Any candidate rejected, either by the Executive Council or at the Annual Meeting, can be reconsidered after two years, after submitting a new application.

These proposed amendments will be voted upon at the AGM on 25 September 2013.

#### **IPSO Masterclasses**

Another successful IPSO masterclass was held at the EUPSA Annual Congress in Leipzig, on June 5th. This annual arrangement looks set to continue, so expect another masterclass at the 2014 EUPSA meeting in Dublin. These masterclasses are popular, and can be over-subscribed, so encourage your trainee surgeons to apply early. The Dublin masterclass will be the first in the 3-year cycle; attendance at each of the 3 years merits a certificate of completion.

The next masterclass will be held at the World Federation of Associations of Pediatric Surgeons (WOFAPS) meeting, to be held in Berlin in October. The Oncology Educational Day will be held on Sunday 14 October, and the main topics will be liver tumors, soft tissue sarcomas & bone tumors. #### **Subscription Update**

It is now more than 2 years since Kenes International took over the management of IPSO's membership. The secretary is pleased with the arrangement, since payment of the annual dues has been much more reliable than previously, and the on-line system encourages members to update contact details.

At the time of writing 118 IPSO members have completed the necessary process for 2013. IPSO is continuing to attract new members, and it is likely that 2013 will be IPSO's strongest year to date, but there are still nearly 50 surgeons who have been IPSO members, but are not currently on the list because of failure to pay the annual subscription. It is likely that some of these would like to continue with membership, but have not provided either the secretary or Kenes with accurate and contemporay contact details. If we have out-of-date contact information then the surgeon will not be receiving this newsletter.

If you are a paid-up member you should be able to view the on-line membership directory, and the secretary woould be grateful if you would have a look to see if any of your colleagues are unexpectedly not included- a quick e-mail to either your colleague

or to the secretary could easily sort out any contact problems of this sort.

Paying annual subscriptions is much easier than it used to be. The membership web pages are very easy to use, and they give alternative methods of paying. #### **Audit of Deaths following Neuroblastoma surgery**

Once more IPSO members are asked to reflect if they have experienced sudden and unexpected/unexplained deaths following surgery to resect a neuroblastoma. The following request has been included in the last three newsletters, but there has not been much response. It is being included for a final time. We will report in Hong Kong regarding the effectiveness of this approach as a mechanism tio investigate rare clinical problems in paediatric surgical oncology.

The last two newsletters asked members to contact Hugo Heij if they knew of any unexpected deaths in young children in the early post-operative period following resection of neuroblastoma. Hugo gave a presentation on this topic in Auckland and in the discussion it was agreed that IPSO would try to audit this problem.

This is a very important issue, which we are unlikely to be able to address without multinational collaboration. Hugo is trying to find common themes in these unusual cases with a bad outcome, hoping to advise on how they can be avoided in future. Please reflect on the operations you have carried out on younger children with neuroblastoma over the last 5 years or so, and if you can recall any unexpected deaths or near-misses please let Hugo know by simply e-mailing him on the following link h.a.heij@amc.uva.nl . Hugo will then get back in touch with you asking for further details.
