Minutes IPSO business meeting (part II)

Friday, october 6, 2000, Amsterdam, NL

- 1. The minutes of the IPSO meeting '99 (Montreal) were arrested without changes.
- 2. Report Martelli of MPO-board Meeting: It had been discussed whether MPO could change it's title from Medical Pediatric Oncology into Medical and Surgical Pediatric Oncology. This appeared impossible for technical reasons.
- 3. The IPSO board discussed the issue of a double MPO subscription for IPSO/SIOP membership with Daniel d'Angio, chief editor of MPO. It was decided that the double subscription now has become voluntarily, and if not wanted, a member can approve for one subscription only. (But if one can afford a double subscription, do so!
