### **Education Day**

### **Report from IPSO-APSA meeting** San Antonio 19-20 May 2012

IPSO joined APSA in May to organise an oncology symposium as part of their education programme. There was good attendance from IPSO members, and the symposium was a tremendous success, with more than 200 delegates. IPSO and APSA have agreed to hold these joint symposia every 4 years, and on this occasion we were all pleased that the quadrennial coincided with the APSA presidency of Bob Shamberger, an IPSO member who was such an excellent host at the Boston congress in 2010.

Dear Friends and Colleages, Dear IPSO Members,

The United States of America is great country, Texas is one of her greatest states, and at the end of this spring San Antonio was the hottest place; this is where APSA hosted IPSO again. The common meetings have become a warm tradition and are more and more scientifically fruitful.

This year the program started with an IPSO-APSA Symposium focusing on neuroblastoma, liver tumors and of course also on other surgical oncology issues. On the next day, we had an educational day on Management of Metastatic Diseases. Excellent lecturers from both IPSO and APSA presented a state of the art in the surgical aspects of treatment of disseminated disease - starting from tactics of surgical treatment (Giovanni Cecchetto), through sentinel lymph node biopsy (Kenneth Gow), standard and innovative technical aspects of metastatectomy (Jörg Fuchs) and hypertermic intraperitonal chemotherapy (Andrea Hayes-Jordan). The audience had really comfortable time to comment and ask the question, which resulted in fascinating discussions moderated by Pete Mattei (APSA) and myself. The main program of the congress was composed of several oral and poster presentations covering full range of pediatric surgery from neonatal surgery, minimally invasive techniques, and basic research to traumatology. Two fantastic guest lectures supplemented the program: by Dan



Green (Robert E. Gross lecture) on evolution of treatment of Wilms tuomor and by Beno Ure (international guest lecture) on minimally invasive surgery and the relationships with classical techniques. One of the last points of the program was debate on challenging cases, where each patient was presented by the moderator and the audience could vote on possible solution. The results and summaries of these opinions were immediately displayed on the screen.

Of course not only science and surgery were attractive in San Antonio. The venue of the congress, the JW Marriot resort & spa, offered fantastic golf courses, swimming pools and "lazy river" where the delegates could relax after sessions. Discussions and meetings continued also in the evenings - during the several official receptions as well as the more private meetings in the hotel garden or restaurants. Texas has also great history, which is still living in the hearts of its citizens. The Alamo battle is one the examples. Visiting San Antonio one should not miss to



walk along the river, but also exploring fascinating history of missions build by Spanish colonisers around the city. After great time spent in Texas, it was a little sad to fly back home, however perspectives for future common meeting are clear and all we will surely meet again.

## **Call for Nominations for IPSO Executive**

Two positions on the IPSO Executive Council come up for election or re-election this year.

- Stephen Shochat reaches the end of his second (final) term as a member of the Executive (member-atlarge)
- Roly Squire has completed a 3-year stint as secretary, and will to stand for re-election.

If you wish to stand for election to one of these posts, or to nominate a colleague, please contact the secretary at <u>roly.squire@leedsth.nhs.uk</u>. Elections will take place at the AGM in London. Candidates must be an active member of good standing (ie have paid their subscriptions) and must be proposed in writing by an active IPSO member.

### **Proposed changes to the IPSO Statutes**

The IPSO Executive Committee is recommending two amendments to the Statutes and By-laws to meet the needs of the organisation in the light of changing circumstances.

- 1. Amendments (1 & 2) to allow the Executive freedom to co-opt any member to fulfil the roles of Programme Director and/or SIOP Scientific Committee Representative. Following reduction in the size of the Executive Committee from 10 members to 8 members in 2008 it has become apparent that it may not always be possible to appoint these posts from the four elected "*members at large*".
- 2. Amendment (3) to address the new on-line application process.

#### Proposed amendments are underlined and in red

 Amendment 1.

 STATUTES:

 ARTICLE 5.

 The Society will have an Executive Council consisting of the Past-President, a President, a President-Elect, a Secretary and/or Treasurer, and four members at-large, included members with a specific portfolio, i.e. Program Director and SIOP Scientific committee Representative. Their terms of office should be two years, except for the Past-President and President-Elect whose terms of office is one year and the Secretary and/or Treasurer whose term of office is three years.

Change to read:

ARTICLE 5. The Society will have an Executive Council consisting of the Past-President, a President, a President-Elect, a Secretary and/or Treasurer, and four members at-large. Their terms of office should be two years, except for the Past-President and President-Elect whose terms of office is one year and the Secretary and/or Treasurer whose term of office is three years.

Amendment 2.

By-LAWS:

ARTICLE 3.4 The Executive Committee will call for nominations from amongst the membership for ad hoc appointments to relevant boards or committees outside the Society in order to represent the interests of the Society. Such appointments will be confirmed at the Annual General Meeting by majority vote and will be for a period of two

years. Such appointees would report on an annual basis to the Executive Committee. Members accepting such appointment <u>may apply for re-election</u> to the position on two occasions.

Change to read:

ARTICLE 3.4 The Executive Committee will call for nominations from amongst the membership for ad hoc appointments to relevant boards or committees outside the Society in order to represent the interests of the Society. The Executive Council will also be able to appoint any full member to be Program Director and/or SIOP Scientific Committee Representative if a suitable candidate is not found amongst the elected members of the Executive Committee. Such appointments will be confirmed at the next Annual General Meeting by majority vote and will be for a period of two years. Such appointees will report on an annual basis to the Executive Committee, and may be invited to meetings of the Executive Committee if appropriate. Members accepting such appointment may be re-appointed to the position on two occasions.

Amendment 3.

BY-LAWS:

ARTICLE 1.1New Members must be proposed by two Active Members in good standing. Application for Membership will be accompanied by a summarized *Curriculum vitae*, and will be sent to the Secretary's office at least two months before the Annual Meeting. Applications fo Active or Associate Membership will be considered at each Annual Meeting of the Executive Council and a recommendation to approve, reject or defer action made by the Council.

Change to read:

1.1 New Members must be proposed by two Active Members in good standing. Application for Membership will be accompanied by a summarized *Curriculum vitae*, and can be carried out on-line through the membership office, or can be sent to the Secretary's office. Applications will be reviewed by the Secretary, who will be able to give provisional approval, following appropriate consultation with members of the Executive Council.

#### The following paragraph will remain unchanged:

1.2 All names of Candidates for Active or Associate Membership, which have been approved by the Executive Council, will be circulated at the next Annual Meeting, an affirmative vote of <sup>3</sup>/<sub>4</sub> of the voting Active Membership present being necessary for confirmation. Any candidate rejected, either by the Executive Council or at the Annual Meeting, can be reconsidered after two years, after submitting a new application.

These proposed amendments will be voted upon at the AGM in October.

#### Audit of Deaths following Neuroblastoma surgery

The last newsletter asked members to contact Hugo Heij if they knew of any unexpected deaths in young children in the early post-operative period following resection of neuroblastoma. Hugo gave a presentation on this topic in Auckland and in the discussion it was agreed that IPSO would try to audit this problem.
